Congratulations! On behalf of the U.S. Department of Veterans Affairs (VA), Center for Verification and Evaluation (CVE), I am writing to inform you that after a review of the submitted documents and other available information, CVE accepts the documentation sent by Caduceus Healthcare, Inc. in response to the Notice of Proposed Cancellation, dated June 9, 2022.

Caduceus Healthcare, Inc. remains verified as a participant in the Vendor Information Pages (VIP) Verification Program database at <https://www.vetbiz.va.gov/>. Caduceus Healthcare, Inc. is eligible to participate in Veterans First Contracting Program opportunities with VA. **This eligibility period is valid through July 2, 2024.** When your current period of eligibility is within 120 days of expiration, you are encouraged to apply for reverification by logging in to your VetBiz VIP profile. Please retain a copy of this letter to confirm Caduceus Healthcare, Inc.'s continued Program eligibility.

While CVE has confirmed that Caduceus Healthcare, Inc. is in compliance with the regulations, Caduceus Healthcare, Inc. must inform CVE of any changes or other circumstances that would adversely affect its eligibility. Eligibility changes not reported to CVE within 30 days could result in a referral to Office of Inspector General (OIG), a referral to the Debarment and Suspension Committee and the initiation of cancellation proceedings all of which could result in the removal of Caduceus Healthcare, Inc. from the VIP Verification Program.

Please be advised that this letter and other information pertaining to Caduceus Healthcare, Inc.'s verification application may be subject to Freedom of Information Act

(FOIA) requests. In addition, all companies approved for the program may be required to participate in a post verification audit.

At any time if Caduceus Healthcare, Inc. discovers one or more NAICS Code(s) that are other than small on its CVE VIP profile, CVE will require all other than small NAICS Codes to be removed within five (5) business days. If these NAICS Codes are not removed within the allotted five (5) business days, CVE may request the U.S. Small Business Administration (SBA) to conduct a formal size determination. In addition, CVE may initiate a referral to OIG, Debarment and Suspension Committee and/or pursue cancellation proceedings. All of the aforementioned referrals and procedures could result in the removal of Caduceus Healthcare, Inc. from the VIP Verification Program.
